PART I - TERMS OF REFERENCE

FOR A CONSULTANT OR A COMPANY PERFORMING RESEARCH ON THE NEEDS AND LIVED EXPERIENCES OF LBTIQ GIRLS, YOUNG WOMEN, AND NON-BINARY YOUTH

A. DELIVERABLES

The subject of this procurement is the collection of information on needs and challenges and experiences of LBTIQ girls, young women, and non-binary youth (aged between 15 and 30 years old), to analyse the impact of factors, such as gender, gender expression, sex characteristics, gender identity sexual orientation and young age in their lived realities. The research is a common projects of IGLYO, the International LGBTQI Youth & Student Organisation and EL*C, the Eurocentralasian Lesbian* Community.

The consultant will design and conduct a European survey to gather the data on the lived experiences of LBTIQ girls and young women and non-binary youth (in education), experiences concerning violence (domestic violence, gender based violence and hate crime and hate speech), their wellbeing (especially mental health status) and socio-economic status. The content of the online survey will be defined in consultation with a selected group of representatives of organisation working on younger LBTI women and girl ("Research Steering Committee"). The consultant will also conduct the quantitative analysis of the data collected via the survey and provide support with the drafting of the final research report. The research will focus on European Union Member States.

The consultant will have to:

- 1. Provide a detailed workplan of the project, including a timeline for the deliverables in line with the proposed timeline of the project.
- 2. Conduct desk research on existing data concerning the specific vulnerabilities of LBTIQ girls and young women, and non-binary youth.
- 3. Draft the content of the online survey in line with the results of the desk research and in consultation with the members of the Research Steering Committee. The online survey will be translated into at least 7 EU languages (the translation will be provided by IGLYO and EL*C). The questionnaire shall take into account the upcoming LGBTI Survey III of the Fundamental Rights Agency of the EU and ensure that the data collected is complementary to that included in the FRA Survey.
- 4. Define a detailed plan for data collection and dissemination of the online survey. The objective is to reach at least 3000 responses from EU Member States. The consultant will take into account the need to collect data from a diverse group of people in terms of ethnicity, origins, citizenship and place of residence, migration status, gender identity and disability.

- 5. Implement the data collection plan, ensuring that the survey and its translation are put online using an appropriate data collection tool and support in the outreach efforts of IGLYO and EL*C.
- 6. Create an online tool for the dissemination of the survey data (e.g. data explorer)
- 7. Support EL*C and IGLYO in the drafting of the research report.

D. ASSESSMENT

Exclusion criteria

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests;
- have been accused of practicing discriminatory or derogatory acts towards the LGBTI community;
- have been accused of human rights violations of any kind;

Eligibility criteria

The consultant shall demonstrate that they fulfill the following criteria (to be assessed on the basis of all supporting documents listed in Section E):

- Demonstrated experience in conducting quantitative and qualitative data collection and analysis with LGBTQI communities and/or other marginalised communities
- Demonstrated intersectional feminist background
- Good understanding of current and past struggles of LBTI women and non-binary persons
- Good understanding of LBTIQ girls and young women and non-binary youth
- Excellent data analysis skills, especially in quantitative data analysis
- Demonstrated experience in the implementation of quantitative data collection and creation of tools to disseminate such data (e.g. data explorers)
- Strong organizational, interpersonal, and project management skills
- Sense of initiative and ability to be self-supporting, including ability to deliver under pressure and within tight deadlines
- Excellent English
- Good knowledge of other EU languages is a strong asset

Award criteria

- Quality of the offer (75%), including:
 - Quality of the proposed technical solutions (60%)
 - Qualification and experience of the staff dedicated to this project (15%)
- Financial offer (25%).

The research will focus on the lived experiences of LBTIQ girls and young women and non-binary youth (in education), experiences concerning violence (domestic violence, gender based violence and hate crime and hate speech), their wellbeing (especially mental health status) and socio-economic status.
